This 2019 plan is part of the 2016-2020 Work Plan that aligns and guides towards an articulated horizon of four years, in which it is conceived with a particular commitment that the construction of more inclusive societies based on a humanistic and innovative vision, mandate of UNESCO that CUDH-UNAM assumes as a renewed commitment.

This plan is also inspired by document 37 C/4 approved by the General Conference of UNESCO and within the framework of the Sustainable Development Goals (SDGs) and the 2030 Agenda.

As a benchmark in the face of the new challenges imposed by the world environment, culture and education are a fundamental pillar for strengthening the foundations of lasting peace and equitable and sustainable development. It should be noted that Mexico has been going through a serious human rights crisis for some years, which has been pointed out by various rapporteurs and mechanisms of the United Nations, at the same time, the Inter-American System has extensive work in defense and promotion in the country.

Accordingly, the main commitment of CUDHUNAM is to implement a cultural project that educates and trains students, professionals, teachers and researchers with excellent academic quality, integrity, responsible, objective, reflective., tolerant, inclusive, sensitive to the gender perspective and the values inherent to human rights, who can develop skills and capacities in the face of the challenges and problems posed by the complex sociopolitical reality at different levels: local, regional, state and international.

In this context, the actions and proposals to be implemented to strengthen CUDHUNAM are: mission and vision of leadership, innovation and challenges; excellence, academic quality and respect for human rights; management, social responsibility and university ethics; strengthening of the teaching, research development, diversity, equality, social inclusion, internationalization, linkage and institutional cooperation.

The tasks covered by these areas are: the transformation of the teaching-learning process, in accordance with the human rights-based approach and the social dynamics that prevail in reality; reinforcing the presence of the CUDH-UNAM in the debate on human rights on the national agenda. and regional; strengthen people's capacity to react to situations of injustice, violence and impunity that deeply damage the social fabric; encourage collaboration networks with national and foreign university agencies and institutions; the incorporation of the human rights approach and the perspective of gender in policies, plans and institutional actions; the development of the skills of the educational community in ICTs; disseminate knowledge and academic research products to promote the integral development of people, finally, the promotion of a critical conscience of sociopolitical thought, to be an example of inclusive behavior and socially responsible.

The report of indicators of the topics sexual and reproductive rights, dissemination of recommendations, integration of the report, training and education in human rights of women in the Public Administration will be prepared. It will also participate and present in the 63rd session of the Commission on the social and legal status of women with a second meeting of the CEDAW Global Network. Monthly newsletters will be prepared to disseminate international mechanisms for human rights and women's human rights, the project website will be kept updated, and microsites for the remaining topics of the 2018 cedaw shadow reports will be prepared.
- 2. Follow-up of the Implementation of the 2030 Agenda in Mexico. Continue the work of monitoring the implementation of the SDGs and the 2030 agenda in Mexico with the network of civil organizations and academic and research instances, which are linked with the Mexican government to influence the application of the objectives at the national, state level and municipal.
- 3. The Ombudsman a tool for citizen participation. Monitoring of women's rights and the gender perspective in the Mexican ombudsman system and the participation of civil society.
- 4. Follow-up to the 2018 Universal Periodic Review (UPR). Follow-up of the recommendations issued to the Mexican State in the framework of the November 2018 support, and the recommendations about the situation of the human rights of women in Mexico prepared by the Unesco Chair of Human Rights.
- 5. Updating the virtual library on human rights and the CUDH-UNAM website. Within the framework of updating the website of the Unesco Chair in Human Rights, the virtual library of human rights and women's human rights continues to be updated.
- 6. Training and Educational Intervention Seminar with a Gender Perspective, Tools against Violence on the University Campus. It currently has a distance education platform on the subject, it has become a benchmark in human rights education in the country and in Latin America.

The UNESCO Chair of Human Rights of the National Autonomous University of Mexico (CUDH-UNAM) based in the Faculty of Political and Social Sciences, was founded on October 9, 1996, as a comprehensive system of research, teaching, study, documentation, promotion, dissemination and defense of human rights in the country, recognized through a collaboration agreement between the United Nations Educational, Scientific and Cultural Organization (UNESCO) and UNAM.
