Executive Summary:

Major outcomes, results and impact of the Chair, including on national policies, in relation to its objectives as stated in Article 2 of the Chair Agreement (between the Institution and UNESCO)

The Cátedra Unesco de Derechos Humanos de la Universidad Nacional Autónoma de México has as its mission to be an instrument that facilitates academic collaboration on human rights among high-level scholars, experts, students and civil society, with researchers from the National Autonomous University of Mexico (UNAM) and other institutions in Latin America and the world

Currently, the CUDH-UNAM has thematic and permanent seminars in various states of the Mexican Republic, which are linked, on the one hand, to various projects with the Cathedral and, on the other, they make up various lines of research and dissemination to respond to the human rights situation in each entity, sharing the same approach and the inescapable responsibility of incorporating the multiculturalism and gender perspective, as well as measures of prevention and attention to gender violence in Higher Education Institutions (HEIs).

Since 2016, the CUDH-UNAM has established a strategy based on the Sustainable Development Goals and the 2030 Agenda, the international human rights mechanisms and the constitutional

reform in Mexico, thereby establishing the following areas of knowledge as its guiding axes for projects and seminars;

- 1) Human Rights within the framework of the 2030 agenda and the internationalization of human rights;
- 2) Empowerment and human rights of women towards a life free of violence;
- 3) Education in Human Rights, science, technology and innovation.

This report presents the results of the 2017 Work Plan:

- The Coordinator of the Cathedra, Dr. Gloria Ramírez, received the recognition "Elvia Carrillo Puerto 2017" for the work she has done to empower Mexican women and advance their human rights, in order to achieve substantive equality. This recognition is granted by the Gender Equality Commission of the Senate of the Republic.
- Participation in the UNESCO Cathedra meeting on the review of the UNESCO Human Rights Strategy and the Integrated Strategy to Combat Racism, Discrimination, Xenophobia and Related Intolerance, to align them with the priorities of the 2030 Agenda and the New Urban Agenda.
- Assistance to the Pre-session of the Committee for the Elimination of Discrimination against Women, in Geneva, in which various topics and proposals were taken to be taken up by the Committee and the Mexican State will be questioned about the fulfillment of the rights of Women in Mexico
- Participation in the alternative report of the Covenant of Economic, Social and Cultural Rights (ICESCR) with the preparation of the chapters on equality and education, in which favorable results were obtained with the recommendations issued by the Committee of experts of the United Nations.
- Follow-up work continues on the Universal Periodic Review Mechanism and its recommendations.
- Follow-up work continues on the recommendations of the CEDAW Committee and the preparation of the shadow report 2018, which led to several seminars and events with civil society organizations and authorities in charge of observing and enforcing women's human rights. .
- In January 2017, a new project sponsored by the UNAM was started, "PAPIIT Project IN308017 Comply to move forward; CEDAW platform with follow-up and outcome indicators (2012-2018) "through which the recommendations of the CEDAW Committee to Mexico will be followed up with an established methodology and with which indicators for monitoring and results will be prepared.

On the other hand, the project made two alternative reports; an intermediate one in 2014 on recommendations 19 and 33 made in 2012 by the Committee to the Mexican government, and another in 2018 to follow up on the issues that were addressed in 2012; dissemination of the recommendations of the CEDAW Committee, integration of reports, coordination mechanisms in the three levels of federal, state and municipal government and on education and promotion of Human Rights.

This plan (2018) is part of the 2016-2020 Work Plan that aligns and guides towards an articulated horizon of four years, in which it is conceived with particular commitment that the construction of more inclusive societies is a mandate of UNESCO that the CUDH-UNAM assumes a renewed commitment, which is part of the construction of more inclusive societies based on a humanistic and innovative vision.

This plan is also inspired by document 37 C / 4 approved by the General Conference of UNESCO and within the framework of the Sustainable Development Goals (SDG) and the 2030 Agenda.

In order to increase and strengthen the impact and knowledge of human rights, the CUDH-UNAM proposes to implement a series of actions whose objective is to adapt to global change, as well as to generate a knowledge society that focuses on studying the main current phenomena and problems, with responsibility, gender perspective, social ethics with a focus on human rights.

As a reference to the new challenges imposed by the global environment, culture and education become a fundamental pillar for strengthening the foundations of a lasting peace and equitable and sustainable development. It should be noted that Mexico has been experiencing a serious human rights crisis for some years, which has been pointed out by various rapporteurs and mechanisms of the United Nations Organization. At the same time, the Inter-American System has extensive work in the defense and promotion in the country.

Accordingly, the main commitment of the CUDH-UNAM is to implement a cultural project that educates and trains students, professionals, professors and researchers with excellent academic quality, integrity, responsible, objective, reflective, tolerant, inclusive, sensitive to the perspective of gender and to the values inherent to human rights, that can develop aptitudes and capacities before the challenges and problems posed by the complex socio-political reality at the different levels: local, regional, state and international.

The education imparted should expand accessibility by considering social interactions and the rapidity in the generation of information. Therefore, the use of Information and Communication Technologies (ICTs) by all agents involved in the teaching-learning process of human rights, is essential to develop their capabilities and skills from a humanistic approach.

In this context, the actions and proposals to be implemented to strengthen the CUDH-UNAM are: mission and vision of leadership, innovation and challenges; excellence, academic quality and respect for human rights; management, social responsibility and university ethics; strengthening of teaching; investigation Development; diversity, equality, social inclusion, internationalization, linkage and institutional cooperation.

The tasks that cover these areas are: the transformation of the teaching-learning process, according to the approach based on human rights and the social dynamics that prevail in reality; strengthen the presence of the CUDH-UNAM in the debate on human rights of the national and regional agenda; strengthen the reaction capacity of people in situations of injustice, violence and impunity that deeply damage the social fabric; encourage collaborative networks with national and foreign university agencies and institutions; the incorporation of the human rights approach and the gender perspective in policies, plans and institutional actions; the development of the skills of the educational community in ICT's; disseminate knowledge and academic research products to promote the integral development of people, finally, the promotion of a critical awareness of socio-political thinking, be an example of inclusive and socially responsible behavior.

In this way, the CUDH-UNAM aims to reaffirm itself as a reference in the deep, critical and proactive analysis for the solution of problems that permeate and violate human rights in Mexico, based on the search for innovative answers and a redefinition of fundamentals tasks oriented to education and culture, as well as their institutional participation in the processes of creation, dissemination and transfer of knowledge.

- Alternate venue of the Facultad de Ciencias Políticas y Sociales (FCPyS). It has an space for 7 people, which has two desktop computers, two laptops, printer, fax line and internet.

From the budget approved by various projects, 1) PAPIIT project IN308017 "Comply to Advance: CEDAW Platform with Indicators of Follow-up and Result (2012-2018)", approved by the Facultad de Ciencias Políticas y Sociales of the UNAM with which five scholarship holders could be supported to carry out the project, stationery and a portable computer were purchased, as well as for the salary payment of an academic assistant, for \$ 355,303.00 y 2) PAICMA project 2014. Project for the elaboration of a training KIT on the Comprehensive Care Program against Breast Cancer in the Distrito Federal (PAICMA), approved by the Institute of Women of the Distrito Federal and project of the National Program of Human Rights Education (PronalEDH 2010-2012), before which a budget for 2017 was obtained for \$ 30,162.63, which hired personnel to carry out said projects.
