The UNESCO chair of human rights of National Autonomous University of México (CUDH-UNAM) aims to be the research center that facilitates the academic collaboration over human rights between high level academics, experts, students and civil society, with researchers of the National Autonomous University of México (UNAM) and other institutions in Latin-America and the globe.

The CUDH-UNAM counts with thematic and permanent seminars inside the university and in diverse country states, that link in one side, with several chair projects, and on the other side the creation of research lines and diffusion to give answer to the situation on human rights in each entity, sharing the same approach and responsibility of incorporate the multicultural and gender

perspective, besides the measures of prevention and attention to gender violence in institutions of higher education.

Since 2016, the CUDH-UNAM established a strategy from the sustainable development objectives and the 2030 Agenda, of the international human rights mechanism, and the constitutional reform of México, and with that establishing the core lines the following fields of knowledge for project and seminars:

- 1) Human rights at the 2030 agenda and the human rights internationalization
- 2) Empowerment and human rights of women to a life free of violence
- 3) Education in human rights, science, technology and innovation

This report represents the working results for 2019:

1. The realization of the 2<sup>nd</sup> encounter of CEDAW global web “sharing experiences on the convention for the elimination of all forms of violence against women implementation”, to reinforce the work with following international organizations in the following of CEDAW convention, that was held in UN hq in NewYork city in the frame of CSW 63, with the support of the national women institute and foreign relations secretary.
2. The realization of the « XIV Anual encounter : the university at the human rights in the XXI century frame. 40 years of the CEDAW Convention and the followings of the recommendations of the committee to México », in the Political and social sciences faculty of National Autonomous University of México, with the participation of civil society organizations and several universities of the country that are part of the project that gives following to CEDAW. The CEDAW got known advances in matter of violence against women, gender violence alerts and feminicides.
3. The realization of the book presentation « Womens and politics in Chiapas, a feminist programme », with the participation of the author and feminist activist of the state of Chiapas, and the presentation was held in the Political and social sciences faculty of National Autonomous University of México.
4. The realization of the event «CEDAW and their recommendations fulfill to advance in womens rights» in the Political and social sciences faculty of National Autonomous University of México and the participation of the CEDAW committee expert, Ms. Magalys Arocha, and with civil society, feminists and academic organizations.
5. The continuation of the following work to the 2018 recommendations of the CEDAW committee through the elaboration of fulfilling indicators in the frame of the project PAPIIT IN308'17.
6. The continuation of the following work on the Periodic Universal Review mechanism and their recommendations.

For 2020 will be continued working on the fields of knowledge on human rights, even tho, the research lines and seminars has been reorganized and some new have been created to answer to the new topics and working groups on 2019 with the purpose of strengthen the protection, diffusion and respect with responsibility, gender perspective, social ethics and human rights approach.

The main compromise of the CUDH-UNAM is to implement a teaching and cultural project that forms and proportionate tools for students, professionals, professors and researchers with top academic qualities, responsible, objective, reflexive, tolerant, inclusive, gender perspective sensitive and all inherent values to human rights, that could develop attitudes and capacities to the challenges and problems inherent to the complex sociopolitical reality on all levels: local, regional, estate and international.

The tasks that this areas represent are: the transformation of the teaching-learning process, with a humans rights based approach and a the reality social dynamics,; reinforcing the presence of the CUDH-UNAM in the humans rights debate at a national and regional level; reinforce the reaction capacity of people at injustice, violence and impunity situations that harm deeply the social tissue; incentivize collaboration webs with national and international universities institutions, the human rights incorporation and gender perspective in the policy, plans and actions; the development of abilities in the teaching community in TIC's; Knowledge and academic research products diffusion to enhance the integral development of people and lats, the promotion of social and political critical thinking, and an inclusive and socially responsible behavior

In this context, the actions and proposals to implement for the reinforcing of the CUDH-UNAM are: 1) leadership vision a mission; 2) innovative and challenging; 3) excellence, academic quality and human rights respect; 4) social responsibility, university ethics, and management; 5) teaching reinforcement; 6) research development; 7) diversity, equality, social inclusion, internationalization, bonding and institutional cooperation.
