### 1. Résumé:

La Cátedra Unesco de Derechos Humanos de la Universidad Nacional Autónoma de México has as its mission to be an instrument that facilitates academic collaboration on human rights among high-

level scholars, experts, students and civil society, with researchers from the National Autonomous University of Mexico (UNAM) and other institutions in Latin America and the world.

Currently, the CUDH-UNAM has thematic and permanent seminars in various states of the Mexican Republic, which are linked, on the one hand, to various projects with the Cathedra and, on the other, they make up various lines of research and dissemination to respond to the human rights situation in each entity, sharing the same approach and the inescapable responsibility of incorporating the multiculturalism and gender perspective, as well as measures of prevention and attention to gender violence in Higher Education Institutions (HEIs).

Within the framework of the Sustainable Development Goals (SDG) and the 2030 Agenda, the strategy of the CUDH-UNAM for the period 2016-2020 is to define an inclusive educational and cultural vision that promotes reflection, dialogue and critical analysis, as well as innovative and substantial issues that answer to the demands and needs of the people.

Since the creation of the new Sustainable Development Goals and the 2030 Agenda, the international defense mechanisms and human rights, the Mexican Constitutional Reform on human rights and the UNESCO medium-term strategy, the CUDH-UNAM has as new guiding axes the fields of knowledge to establish their lines of research, projects and seminars;

- 1) Human Rights in front of the 2030 agenda and the internationalization of human rights;
- 2) Empowerment and human rights of women towards a life free of violence;
- 3) Education in Human Rights, science, technology and innovation.

This report presents the results of the 2016 Work Plan.

We participate in the Sixth International Forum of NGOs in Official Association with UNESCO "From promoting to building peace with NGOs"

We continue with the systematization and analysis of the recommendations made by the Universal Periodic Review (UPR) to the Mexican State on the issues of education and human rights of women. Likewise, we concluded with the PAPIIT Project "Follow-up and Impact of the Convention on the Elimination of All Forms of Discrimination against Women in Mexico and Ciudad Juárez", that with the support of UNAM 2016 we were able to consolidate an intermediate report on two specific recommendations, which is already published by the University. At the same time, the methodology for monitoring the recommendations of the CEDAW Committee to Mexico was developed and compiled on a compact disc.

The updating of the CEDAW site continued and electronic bulletins on gender and human rights were made, contributing to the formation of the university community in this regard.

In terms of teaching, the course entitled "International Feminist Policy" was held, which aimed to inform and train members of feminist civil society organizations, researchers, academics, civil servants and the public in general on the importance of the 2030 Global Development Agenda and its connection with women's rights agendas; as well as to elaborate an analysis and reflection of these in light of the follow-up to the Convention on the Elimination of All Forms of Discrimination against Women (CEDAW) in Mexico and the preparation of shadow reports.

In terms of inter-institutional collaborations and networks, Cathedra works in thematic seminars and specialized seminars, which carry out various research and teaching activities in collaboration with different academic institutions, NGOs or public institutions, among which are:

This work plan includes activities that derive from having the title of the Cátedra UNESCO de Derechos Humanos de la UNAM (CUDH-UNAM), which is a comprehensive academic space for research, teaching, study, documentation, promotion, defense and dissemination on human rights recognized by UNESCO. The CUDH-UNAM seeks to be an instrument that facilitates academic collaboration on human rights among high-level researchers, experts and academics, students and civil society with researchers from the Universidad Nacional Autónoma de México (UNAM) and other institutions in Mexico, Latin America and in the world. Its general objective is: to constitute an academic space for reflection, analysis, research on human rights in the Facultad de Ciencias Políticas y Sociales, from an interdisciplinary approach of the Social Sciences that links the contributions of researchers, academics and members of Non-Governmental Organizations and public and private institutions for the strengthening and defense of human rights in the Faculty, the UNAM and in the country.

In this sense, the CUDH has as new guiding axes the following fields of knowledge:

- 1) Human Rights within the framework of the 2030 agenda and the internationalization of human rights;
- 2) Empowerment and human rights of women towards a life free of violence;
- 3) Education in Human Rights, science, technology and innovation.

#### *FORMATION AND TEACHING*

In terms of formation, the following Seminars will be held, and at the same time the Seminars of collaboration agreements with other Institutions of Higher Education will be continued:

- **Seminar to follow the obligations of the Mexican State in the framework of CEDAW**
- **Seminar on gender violence to coexistence in the high and university education system**
- **Seminar on the Decade of Human Rights Education**
- **Seminar on the Ombudsman, a tool for citizen participation**
- **Seminar on Emerging Human Rights, Defense and Protection of human rights from civil society**
- **Seminar Mexico before the international agenda of human rights**
- **Seminar on Business and Human Rights**
- **Seminar on the Decade of Human Rights Education and good practices**
- **Seminar on Peace and Human Rights Research**

The CUDH-UNAM also has permanent Human Rights Seminars in various institutions of higher education (HEIs): Universidad de Occidente, in the Universidad Autónoma Benito Juárez de Oaxaca; the Permanent Seminar on Health, Bioethics and Human Rights in the Benemérita Universidad Autónoma de Puebla, in the Universidad Juárez Autónoma de Tabasco and the Universidad Autónoma de Chiapas.

It is within the framework of all these seminars that the research works included in the report are developed, and with which it will continue for 2017.

**Online Course:** The CUDH-UNAM since 2010 has consolidated the teaching activities through its virtual platform, so that for the year 2017 has been made, in a general way, the update of its online educational offer, in a comprehensive manner, enhance and enrich it with new Contributions, through:

- Diploma in Distance Education in Human Rights.
- Distance Diploma on Gender Perspective in Education and Women's Access to a Life Free of Violence.
- Diploma on the International Law of Human Rights. Fourth generation (in connection with the new seminar).

#### **Teacher formation in human rights:**

In view of the implementation of the Reform of Plans and Programs of Study and of the General elective subjects of citizen education and human rights and of gender theory in the Faculty of Political and Social Sciences, two courses for the teaching staff will be designed and carried out. Likewise, will continue participating in the Master of Critical Gender Studies in the Postgraduate Program.

#### **RESEARCH**

The research projects that will have their development during 2017:

1. Conclusion of the third year of the PAPIIT Project IN307814 about: Follow-up and Impact of the Convention on the Elimination of All Forms of Discrimination against Women in Mexico and Juarez City. This project considers that, on the one hand, there are de facto compliance mechanisms of Mexico's obligations in the federal and state public administration. On the other hand, there is a lack of an effective mechanism in charge of the Mexican State to follow up on the recommendations of the CEDAW Committee, which favors a culture of simulation, instead of a compliance culture that would contribute to favoring the exercise of the rights of women and the design of adequate policies to respond at the same time to the serious situation of violations of women's rights in the country and to Mexico's commitments in this area.

This project is linked to other projects and lines of research such as:

- Follow-up of the International Recommendations on education to the Mexican State, through which we will update the book "Cumplir para avanzar" that includes recommendations to the Mexican State on women's rights.
- Monitoring of the PAPIME Project 306511 Education Training and Intervention with a Gender Perspective Tools against Violence on the University Campus, in this framework we are going to publish the research "A shadow runs through the university campus: gender violence", and we will develop our dissemination campaign "Zero tolerance of gender violence in the UNAM". In the same way, we will enrich the corresponding website and in particular what is referred to "What to do in case of violence?" We will also publish the "Guide on the prevention of gender-based violence in the UNAM".
- Follow-up to the International Recommendations on the Universal Periodic Review (UPR) and follow-up of the International Recommendations on the Covenant on Economic, Social, Cultural and Environmental Rights in the field of Education. We hope to publish the UPR manual.
- We will continue with the Project and line of research on "The Ombudsman a tool of Citizen Participation", project that follows the Mexican Ombudsman System in particular this year on compliance with CEDAW and its relationship.
- Thus, to the PAPIIT project indicated above, this project will seek to monitor the relations of the OHCHR with civil society and in compliance with the CEDAW.

2. Start of the new PAPIIT project IN308717 "Comply to advance: CEDAW Platform with Indicators of follow-up and results (2012-2018)"

3. The Ombudsman a tool for Citizen Participation. Project that tracks the Mexican Ombudsman System, in particular this year, on compliance with CEDAW; linked to the PAPIIT project mentioned above. This project will seek to realize a monitoring of the relations of the OHCHR with civil society and in compliance with the CEDAW.

4. The project of the National Program of Education in Human Rights and Culture of Peace for 2016-2018 will be followed up, and participate in the Human Rights Program of the Distrito Federal, in particular in the chapter of Education promoting the creation of a Program in the matter for the Distrito Federal and the fulfillment of the constitutional reform in the matter of Human Rights of 2011. Several activities have been contemplated in this project, such as: relaunching the EDH Educators and Trainers Network, update of the Diagnosis of Human Rights Education in Mexico, update of the website questionnaire, preparation of a CD of diagnoses of human rights education in 2014, and the publication of electronic monthly bulletins on the CUDH-UNAM. In addition to enriching the digital heritage on human rights education with bibliographic, didactic and information materials for students, teachers and other educational agents

5. Follow-up will be given to the recommendations that the Mexican State has regarding education and training, and the book will be updated: "The pending task"

6. The 2030 Sustainable Development Agenda will be followed up in Mexico, as will the United Nations Convention on Climate Change COP 21. Follow-up on Compliance with the Beijing Platform for Action in Mexico, in collaboration with civil society networks and HEIs, will seek to have a special impact on the FCPyS, where several events on the subject are planned.

5. Follow-up with the National Citizen Observatory of Femicide will be followed up on the follow-up of Femicides in the Distrito Federal.

## DIFFUSION

Regarding dissemination activities, the following actions are planned:

- Conduct the annual Colloquium of the CUDH-UNAM and include the progress and research on FROM VIOLENCE TO TOLERANCE IN THE HEI's
- Conduct the CEDAW Seminars by videoconference with a wide call and use the videoconference of the Faculty and the Webcast system, update the web site and develop more widely the diffusion in networks.
- Improve and reproduce the informative brochure Zero Tolerance of Sexual Violence at the UNAM, so that students know the instances to which they can turn if they are victims of sexual harassment.
- Develop social networks and other tools for dissemination and prevention of gender violence.
- Disseminate and present the Guide to the Prevention of Gender Violence in UNAM and encourage the development of research in the other HEIs that were part of the PAPIME project(UANL, UACH, UdeO, UJAT and UNAM).
- Participation in the Clara Zetkin awards, this microsite was created which aims to publicize in a consolidated manner and within the framework of this award, in 2016.
- Conducting a Colloquium on experiences to prevent and address gender-based violence in High school and High Education Institutions.
- Realization of the XI Encuentro: The University before the Paradigm of Human Rights in the XXI century and the XII Meeting of the Network of Teachers and Researchers of Human Rights in Mexico
