The Unesco Chair in Human Rights of the National Autonomous University of Mexico is a research center that facilitates academic collaboration on human rights between high-level

This 2021 plan is part of the Collaboration Convention with UNESCO and the agreement on the renewal of CUDH-UNAM with UNECO, which is oriented towards a commitment to the construction of inclusive societies based on a humanistic and innovative vision, in accordance with THE statutes and regulations of UNAM, the mandate of UNESCO and sane with the fields and lines of research , which are assumed as their main commitments.

By 2021, human rights knowledge fields, lines of research and seminars will continue to be worked on, including some new reflection seminars that respond, to the current context we are socially experiencing arising from the COVID 19 Pandemic and to the updating of the topics and working groups we have set up during 2020 with the aim of strengthening their protection , dissemination and respect, with a gender perspective, social ethics and with the human rights-based approach.

The main commitment of CUDH-UNAM is to implement an educational and cultural project that trains and provides tools for students, professionals, teachers and researchers with excellent academic quality, responsible, objective, reflective, tolerant, inclusive, sensitive to the gender perspective and values inherent in human rights, who can develop skills and capacities in the face of the challenges and problems posed by complex socio-political reality at the different levels: local, regional, state and international.

The tasks covering these areas will continue to strengthen the teaching-learning process with a human rights and gender perspective approach in all my teaching, research and outreach activities, as well as seek to influence public policies to strengthen the presence of CUDH-UNAM and the Faculty of Political and Social Sciences in the debate, reflection, development and proposal of alternatives and initiatives from human rights to incorporate them into the national agenda regional and international.

In this way, CUDH-UNAM continues to re-adhere as a benchmark in the in-depth, critical and proactive analysis for the resolution of problems that permeation and violate human rights in Mexico, based on the search for innovative responses and a redefinition of fundamental tasks oriented to education and culture, as well as in its institutional participation in the processes of creation, dissemination and transfer of knowledge.

In this context, by 2021 I will continue to develop 3 fields of knowledge, research lines and new seminars. The fields and lines of research will be:

It will continue with the follow-up of the students who perform undergraduate and postgraduate theses and are collaborating in the PAPIIT IN310820 project "Observatory of Compliance of the CEDAW Convention in Mexico 2018-2022" in charge and under my tutoring, as well as my participation in colloquiums and tutoring committees.

The research projects that were developed in 2020 will continue and the activities proposed for them in 2021 are as follows:

1. PAPIIT PROJECT IN310820. Observatory on Compliance with the Convention on the Elimination of All Forms of Discrimination against Women (CEDAW) in Mexico 2018-2022. During 2021, this project will continue to be implemented; to implement the methodology of the indicators is monitored and results of the CEDAW platform to assess compliance with the partial recommendations of the CEDAW Committee to Mexico, as well as to systematize and publish through methodological guides the information in 2021 for the preparation of the shadow reports on the occasion of Mexico's 10nd periodic report to CEDAW in 2022.

By 2021 methodological guides will be developed on the topics: (a) Child marriage; b) Domestic workers; c) Disappearance; d) Gender-based violence, femicide and Alerts of gender-based violence; (e) Gender-based education and training; (f) Mortality and women imprisoned for abortion; (g) Political rights; (h) follow-up to Recommendations of Ciudad Juarez; (i) Peace Agenda, within the framework of this project; dissemination will be given to the implementation of international mechanisms and instruments for the defence and promotion of women's human rights at the national level; I know will publish a monthly specialized newsletter that serves as an information reference in this area and will update the project website that presents the information and products of the project.

On the other hand, the CEDAW Citizens Network at the national level and the CEDAW Global Network at the international level will also be strengthened through a parallel session at the UN Women's Social and Legal Commission to continue the exchange of experiences of followup to recommendations through virtual platforms due to the context of the pandemic.

Various activities will be carried out for the 2020 Partial Shadow Report seminar on femicide and gender-based violence alerts and CEDAW, in collaboration with the Mexican Federation of University (FEMU), the CEDAW Citizens Network and the National Network of Alertists, with the latter, the monitoring and conduct of regional and state talks will continue to be considered, whose objective is to present the situation and balance of AVGM in each federal entity, its evolution, obstacles and challenges, as well as an overview of gender-based violence.

In addition, continued dissemination of the implementation of international human rights mechanisms between the university community and civil society organizations will be continued with the support of the PAPIIT academic committee through the 2021 annual meeting.

The outreach activities for 2021 are as follows:

- An event will be held for the 25th anniversary of the UNESCO Chair of Human Rights
- The Annual Meeting XVI "The University to the Human Rights Paradigm: Mexico to the CEDAW Report in the Medium Term 2020" will be held on the follow-up to CEDAW recommendations through the specific seminars on the topics worked on during the last 6 years (Child Marriage; Domestic workers; Disappearance; Gender-based violence, femicide and Alerts of gender-based violence; Gender-based education and training; Mortality and women imprisoned for abortion; Political rights; follow-up to recommendations of Ciudad Juarez; And the Peace Agenda).
- Seminar sessions will be held in the three fields of knowledge and lines as established in each of the seminars, such as: business, human rights and gender, Marcela Lagarde on training and educational intervention with a gender perspective, anti-violence tools on the university campus, etc.
- Follow-up seminars on CEDAW recommendations by videoconference, as it is not feasible for the current pandemic to hold events in person with society organizations and universities for the follow-up to the CEDAW 2022 Shadow Report on the follow-up to recommendations on the occasion of the Mexican State's X periodic report to the CEDAW Committee.
- Disseminate and present the Diagnosis on the incorporation of gender studies into the social sciences in the subjects of study of the careers of the Faculty of Political and Social Sciences 2014-2020 and promote the development of research in the other IES that were part of the Seminar Training and Educational Intervention with Gender Perspective Tools Against Violence on the University Campus (UANL, UACH, UdeO, UJAT and UNAM).
